In total, Rebuilding Together has invested more than \$4,000,000 into revitalizing low-income homes, community facilities and neighborhoods in Solano County.

During a project, local businesses, community members and concerned residents come together from all walks of life to rehabilitate homes and community facilities in Solano County. This is accomplished with volunteer labor—both skilled and unskilled—donated materials/services and financial support from within the county. Since June, 2009, Rebuilding Together has rehabilitated 27 homes for low-income homeowners (disabled / seniors / military) and held more than 36 community facility workdays in Solano County. Total value of rehab work donated by RTSC and our volunteers exceeds \$4 million.
