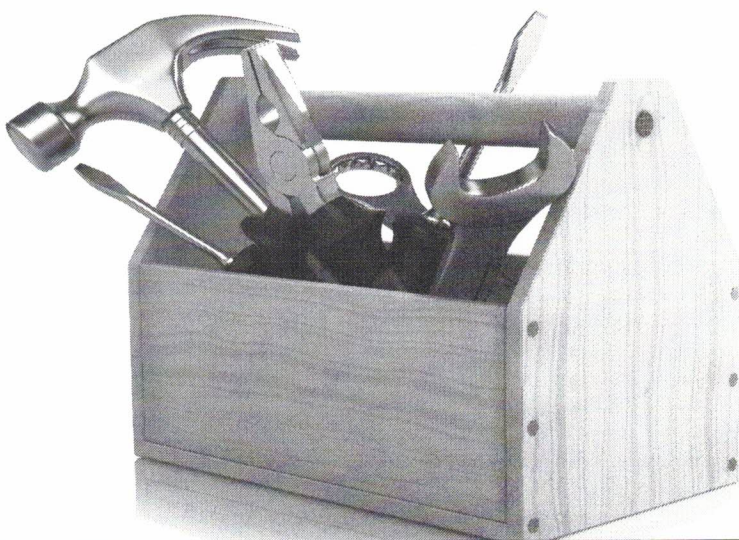

During a project, local businesses, community members and concerned residents come together from all walks of life to rehabilitate homes and community facilities in Solano County. This is accomplished with volunteer labor—both skilled and unskilled—donated materials/services and financial support from within the county. Since June 2009, Rebuilding Together has rehabilitated 40 homes for low-income homeowners (disabled / seniors / military) and held more than 50 community facility workdays in Solano County.
